**Re: Electronic Application of Kentucky Utilities Company for Approval of Its 2020 Compliance Plan for Recovery by Environmental Surcharge - Case No. 2020-00060**

Dear Mr. Chandler:

Please find enclosed and accept for filing Kentucky Utilities Company's ("KU") statement confirming the timing for filing status reports and revised ES Forms in electronic medium to conform to the Commission's Order dated September 29, 2020 in the above-referenced matter.

Ordering Paragraph 7 requires KU to submit a status report on its 2020 ECR Plan every three months from the date of the Order issued on September 29, 2020. In Ordering Paragraph 9, the Executive Director is delegated the authority to grant a reasonable extension of time for filing said status report. KU respectfully requests to submit the status reports no later than 30 days following the end of each calendar quarter with the first report to be filed no later than January 30, 2021. This timing will align the filing of the status report for the 2020 ECR Plan with the status reports being filed as part of the 2016 ECR Plan and the Trimble County Landfill.

In addition, KU proposes the following additional revisions to the attached ES Forms to conform to Ordering Paragraph 4 that establishes the ROE for the 2020 ECR Plan:

- On ES Form 1.10, the calculation of the 2009, 2011 and 2016 ECR Plans' revenue requirement (E(m)) is separated from the calculation of the 2020

ECR Plan revenue requirement. A subtotal line has been added to this form which results in changes in line numbering;

- On ES Form 1.00, line number references are updated due to the line numbering changes on ES Form 1.10;
- On ES Form 2.00, the calculation of the 2009, 2011 and 2016 ECR Plans' rate base is separated from the calculation of the 2020 ECR Plan rate base; and
- On ES Form 2.40, the calculation of the 2009, 2011 and 2016 ECR Plans' cash working capital allowance is separated from the calculation of the 2020 ECR Plan cash working capital allowance.

Pursuant to the terms of the Order, KU will implement the revised ES Form changes with the September 2020 expense month filing to be submitted on October 16, 2020.

In accordance with 807 KAR 5:001, Section 8, this is to certify that the electronically filed documents are a true and accurate copy of the same documents being filed in paper medium subject to the terms of the Commission's March 16, 2020 and March 24, 2020 Orders in Case No. 2020-00085 ("Electronic Emergency Docket Related to the Novel Coronavirus COVID-19") ("COVID-19 Orders"); that the electronic filing has been transmitted to the Commission on October 9, 2020; that there are currently no parties in this proceeding that the Commission has excused from participation by electronic means; and that the original in paper medium of this filing will be delivered to the Commission consistent with the COVID-19 Orders.
