## **Property Acquisition Update**

Kentucky Power files with the Commission its December 2020 property acquisition update. The filing is being made in accordance with paragraph 36 of the Company's application. The update details the status of Kentucky Power's property acquisition efforts as of November 30, 2020. Much of the information supplied by this report was filed on December 2, 2020 in the Company's response to KPSC 2-2. Consistent with the Commission's December 29, 2020 Order in this case, Kentucky Power is filing this stand-alone December 2020 property acquisition report.

Land records, the use of non-metes and bounds property descriptions in many of the title documents, along with extensive changes to the surface of the parcels resulting from mining and other activities, make identification of property boundaries and ownership in the project area more difficult than in some other areas of the Commonwealth. The Company filed its application based on the records in the offices of the relevant Property Valuation Administrators in conformity with the Commission's regulations. The Company's ongoing title and survey efforts have required, and likely will continue to require, ongoing modification of the filings related to parcels affected by the Company's proposed transmission line and right-of-way.

Ongoing survey and title work since the November 2020 update, as well as the removal

of parcels to be acquired solely for access roads from the report, eliminated nine parcels that were included in the November 2020 update. The eliminated parcels and the reason for their elimination is detailed below:

The Company is seeking to acquire 26 parcels<sup>3</sup> for use in connection with the

transmission line and right-of-way. It has acquired to date seven of the 26 parcels.

The Company formerly filed two exhibits to each month's update. As a result of survey

Mining and any reclamation efforts displaced or destroyed many of the "monuments" described in the applicable deeds and other title documents. Based on preliminary title and survey work, the Company concluded that Parcel Ref. No. 17 was outside the area affected by the transmission line and right-of-way. The Company thus removed Parcel Ref. No. 17 in its November 2020 update. Based on further work, including review of unrecorded mining documents, the Company has further updated the parcel boundaries. The revised boundaries indicate Parcel Ref. No. 17 comprises Parcel Ref. Nos. 18, 20, and 21, and that Parcel Ref. No. 17 is affected by the transmission line or right-of-way. Parcel Ref. No. 17 is correctly located on revised Exhibit 6 filed on December 2, 2020 in connection with the Company's response to KPSC 2-2(b).
