EAST KENTUCKY POWER COOPERATIVE, INC.'S
MOTION FOR AN EXTENSION OF TIME TO MAKE CERTAIN ANNUAL FILINGS

Comes now East Kentucky Power Cooperative, Inc. (“EKPC”), by counsel, pursuant to the Commission’s March 16, 2020 Order in the above-styled docket and does hereby request relief from the Kentucky Public Service Commission (“Commission”) regarding the extension of certain upcoming deadlines for filing certain annual reports and updates, respectfully stating as follows:

In response to the Novel Coronavirus COVID-19 pandemic, EKPC has taken certain steps to isolate key personnel and avoid congregations of employees in accordance with guidance issued by the United States Centers for Disease Control and Prevention. These and other efforts have been undertaken to assure continuity of service to EKPC’s Owner-Members, which remains EKPC’s top priority. However, the company also has several annual reporting deadlines that are due to be filed on March 31, 2020 and April 1, 2020. In order to focus upon maintaining essential utility operations and minimizing the possibility of spreading the COVID-19 virus within EKPC’s workforce, EKPC respectfully requests the Commission to enter an Order giving it an additional thirty (30) days to make the following annual reports:

- 1) Economic Development Report, as required by Case No. 2014-00034 and Case No. 2016-00316;
- 2) Bluegrass Generating Station Annual Operating Report, as required by Case No. 2015-00267;

- 3) Nucor Gallatin Steel Demand Response Report, as required by Case No. 2013-00174;
- 4) AGC Interruptible Contract Report, as required by Case No. 2015-00422;
- 5) Annual ARO Calculations Report, as required by Case No. 2014-00432 and Case No. 2018-00027;
- 6) Annual ARO/Regulatory Asset Report (Related to Environmental Compliance Plan Projects 5 and 10), as required by Case No. 2015-00302;
- 7) CoGeneration Tariff Updates;
- 8) Cost Allocation Manual Update;
- 9) 2019 RECC Report of Gross Operating Revenues;
- 10) Annual Financial and Statistical Report; and
- 11) Annual Report for Administrative Case 387.

While it is possible that EKPC may file one or more of these reports prior to the existing deadline, EKPC respectfully requests a thirty (30) day extension of time – April 30, 2020 – to tender each of the above-listed annual reports or tariff updates.
