REQUEST NO. 1: Refer to the application, Attachment 4. State the source of the revenue labeled Management Fees on the pro forma income statement.

RESPONSE: The revenue labeled Management Fees on the pro forma income statement is for service provided to Clay Gas Utility District. Sentra receives \$0.50/Dth of natural gas used by their customers.

REQUEST NO. 2: Refer to the response to Commission Staff's Second Request for Information, Item 2(b), the attached Nonrecurring Charge Cost Justification sheet.

a. For Item B, Labor, provide a detailed list of items that is included in the two hours of labor costs for the total that equals the \$84.00 amount.

b. For Item B, Miscellaneous, provide a detailed itemized statement for the \$25.00 amount.

RESPONSE:

a. The two hours of labor for a disconnection/reconnection is estimated as follows. The trip(s) could include two employees. The estimated time is for one employee.

Disconnection trip:	Round trip travel time	45 minutes
	Check for leaks and lock meter	15 minutes
Reconnection trip:	Round trip travel time	45 minutes
	Remove lock and check for leaks	15 minutes

b. The \$25.00 Miscellaneous charge is for transportation to and from a customer's location to disconnect and reconnect. Such a round trip in our service area could be anywhere from 20 to 30 miles. At \$0.58/mile, the actual charge would range from \$11.60 to \$17.40.

Disconnection trip:	Round trip mileage at \$0.58/mile	\$12.50
Reconnection trip:	Round trip mileage at \$0.58/mile	\$12.50
