ANSWER: There does exist a discrepancy between that number of active

customer connections stated in Item 1 of this request multiplied by the per customer per month surcharge. Southern reached out to their billing software company to inquire about said discrepancy. The billing software explained that it was due to customers having unapplied credits on their accounts due to overpayments. Additionally, Southern does not charge the surcharge to Southern's wholesale water customers, like Knott County Water and Hindman City Water.
