This creates a higher demand charge on the 10 wholesale bill that will not be offset by relatively low energy-related retail revenues. 11 From the test year, an example of when Meade County experienced rate volatility 12 due to existing rates not aligning with cost-based rates is the month of October 2019. 13Meade County's annual load factor for wholesale 2019 billing was 56 percent. The 14highest monthly load factor was 65 percent in July and the lowest was 47 percent in 15October. Because Meade County has fixed costs incorporated into its retail energy 16 charge, the cooperative experiences rate volatility in months like October 2019 when 17billing demands (and thus wholesale demand charges) are high but overall energy sales 18 are low. 6 **Response**) Meade County has always attempted to take advantage of lower interest rates 7 when available by actively communicating with representatives from Cooperative Finance Corporation ("CFC") and the Rural Utility Service ("RUS") on a routine basis. In these 8 discussions, we have requested our lenders perform periodic reviews of our loan portfolio to see 9 10 if we can lower our borrowing cost, but unfortunately, market conditions have not always been 11 cost beneficial to refinance our entire debt. However, we continue to evaluate repricing and/or 12refinancing opportunities to benefit financially from more favorable interest rates. Recently, 13 Meade County has attained lower interest rates by repricing several short-term variable rate 14maturities at longer repayment timelines to avoid interest rate volatility in the future. By 15proactively executing these low interest long-term fixed loans, it has safeguarded the 16 Cooperative by minimizing our refinancing risk that was associated with short-term variable rate 17 financing by avoiding a rise in interest rates and by creating a more stable funding option. 
