AMENDED APPLICATION

On June 8, 2020, Southeast Daviess County Water District (“Southeast Daviess District”) filed an Application with the Kentucky Public Service Commission (“Commission”) for a deviation from the requirements of 807 KAR 5:066, Section 16(1) regarding the frequency of testing its 5/8- x 3/4-inch Sensus SRII meters. Southeast Daviess District hereby amends the Application to reflect more accurate cost savings than those estimated in the original Application. Southeast Daviess District amends its Application as follows.


1. In Appendix B of Southeast Daviess District’s Application, Southeast Daviess District provided cost savings calculations associated with its sample meter testing plan. In footnote 8 on page B-2, Southeast Daviess District explained that the number of meters used in the calculations was approximate because it was awaiting a system update from its software provider, United Systems. United Systems released its system update and Southeast Daviess has now updated its cost savings to reflect the correct meter numbers.

2. An updated **Appendix B** is attached. Southeast Daviess District also updates the references to the cost savings on page 7 of the Application and page 9 of Appendix A to reflect the updated cost savings of \$138,720.

3. Except as modified herein, Southeast Daviess District's original Application, all Exhibits, and all Appendices remain true and correct.


