**MOTION TO EXCUSE THE ATTENDANCE OF
WITNESS RANDY GAY AT THE SCHEDULED HEARING**

Hyden-Leslie County Water District (“Hyden-Leslie District”) moves the Public Service Commission for an order excusing Randy Gay from appearing at the hearing scheduled for October 14, 2020. In support of its motion, Hyden-Leslie District states:

1. Mr. Gay is a member of the Hyden-Leslie County Water District Board of Commissioners.
2. On September 18, 2020, the Public Service Commission issued an Order in which it directed Mr. Gay to appear at the hearing scheduled in this matter.
3. On September 29, 2020, Commission Staff obtained a subpoena for Mr. Gay to appear and testify as a witness at the scheduled hearing.
4. Mr. Gay is scheduled to undergo surgery on October 13, 2020.
5. Mr Gay’s physician has advised that Mr. Gay should refrain from work for 14 days following the surgery. A copy of his guidance is attached to this Motion.
6. Mr. Gay is one of five members of Hyden-Leslie County Water District Board of Commissioners directed to appear at the scheduled hearing and to whom Commission Staff has issued a subpoena to testify before the Public Service Commission. His testimony is likely to duplicate that of the other Board members. Mr. Gay did not play any role in preparing Hyden-Leslie District’s application for rate adjustment or its responses to the Commission’s Order of


June 18, 2020 or Commission Staff's Request for Information. Therefore, his absence should not lessen or restrict the Public Service Commission's ability to conduct its inquiry.

7. If the Public Service Commission finds that Mr. Gay's testimony is necessary to its inquiry, Hyden-Leslie District respectfully requests that alternative means of taking that testimony be considered that would allow Mr. Gay to respond to questions without having to travel to the Public Service Commission's offices in Frankfort.

WHEREFORE, Hyden-Leslie County Water District requests that Mr. Randy Gay be excused from appearing at the scheduled hearing in this matter and that subpoena requiring his appearance be withdrawn


