
**STIPULATION**

Commission Staff and Hyden-Leslie County Water District stipulate the following:

1. Jason Pennell is an employee of the Kentucky Rural Water Association (“KRWA”) and, in the course of his duties with KRWA, assisted Hyden-Leslie County Water District in the preparation of its application for rate adjustment.
2. Mr. Pennell is responsible for the preparation of Exhibit Q of Hyden-Leslie County Water District’s application, which addresses revisions to the Hyden-Leslie County Water District’s nonrecurring charges.
3. Mr. Pennell is also responsible for the preparation of Hyden-Leslie County Water District’s Responses to Requests 19 through 23 of the Commission’s Order of June 18, 2020.
4. If Mr. Pennell were called as a witness to testify before the Commission, he would adopt as his testimony Exhibit Q of the Application as well as the responses to Requests 19 through 23 of the Commission’s Order of June 18, 2020.
5. Mr. Pennell would further testify that each of the proposed nonrecurring charges yields only enough revenue to pay the expenses incurred in rendering the service for which it is charged.




