

SUBMISSION OF RATE CASE EXPENSES
AND REQUEST FOR RECOVERY

Hyden-Leslie County Water District (“Hyden-Leslie District”) submits evidence of its rate case expenses in this matter. As of this date, Hyden-Leslie District has incurred rate case expenses of \$22,814.70. It proposes that these expenses be amortized over a three-year period and that the test period revenue requirement be increased by \$7,604.90 to reflect the amortization of these expenses. An itemized listing of rate case expenses is attached as Exhibit A. The invoices supporting each expense are attached as Exhibit B.


