This letter is to inform you that Martin County Water District made zero (0) purchases from Evans Hardware in Quarter 4 of 2024.

Alliance Water Resources made sixteen (17) purchases in Quarter 4 of 2024.

On 10/9/24, \$19.59 was spent on CPVC pipe and glue for pipe work for a meter tie in at Collins Creek. On 10/15/24, \$36.89 was spent on Bolts, Nuts, and washers for 40E pump station expansion joint pump 1. On 10/15/24, \$21.16 was spent on light bulbs for 40E pump station. On 10/16/24, \$5.75 was spent on a ground lug and bolt for wiring of 40E pump station motor. On 10/16/24, \$57.66 was spent on bolts, nuts, and washers for 40E pump station expansion joint pump 2. On 10/16/24, \$77.02 was spent on a 1" CTS adapter for a service line repair. On 10/25/24, \$63.58 was spent on tie down rachets for barrels on the suction line for the diesel pump at the Raw Water Intake. On 10/25/24, \$75.90 was spent on bolts, nuts, and washers for the suction and discharge hoses at the raw water intake. On 10/28/24, \$151.97 was spent on sandbags and rachet straps for floating pontoon intake screen at the Raw Water Intake. On 10/30/24, \$185.50 was spent on a trencher rental for a tap installation on Cold Water. On 10/31/24, \$364.59 was spent on a culvert needed for replacement after a main line repair on Old Route 3.

On 11/12/24, \$12.16 was spent on a brass fitting for the diesel pump pressure gauge at the Raw Water Intake.

On 12/5/24, \$24.99 was spent on a ball valve and a 90-degree swivel for 40W pump station suction pressure gauge. On 12/6/24, \$33.14 was spent on a heat lamp fixture and heat bulb for Little Blacklog Pump Station winterizing. On 12/6/24, \$20.13 was spent on a GFCI receptacle for Little Blacklog Pump Stations winterizing. On 12/18/24, \$94.73 was spent on split bolt connectors and electrical tape to wire up motor at 40W pump station. On 12/18/24, \$74.19 was spent on a chain hoist to leave installed at 40W pump station to move and install motors.
