This letter is to inform you that Martin County Water District made zero purchases from Evans Hardware in the past 30 days.

Alliance Water Resources made four (4) purchases in April 2023. On 4/6/23, \$66.77 was spent on a lanyard for a safety harness and \$26.99 was spent on a lock and chain for the reservoir gate. On 4/10/23, \$52.18 was spent on nuts, bolts, and sockets for use at the raw water intake. On 4/25/23, \$13.97 was spent on pipe cement and primer for replacing chemical delivery lines at the WTP.
