This letter is to inform you that Martin County Water District made zero (0) purchases from Evans Hardware in the past 30 days.

Alliance Water Resources made seven (7) purchases in June 2023. On 06/02/23, \$95.39 was spent on 2-way radios for flagging operations and \$27.53 was spent on sealant and a vent for Spicy Ridge pump station. On 06/06/23, \$4.44 was spent on brass connectors and \$5.82 was spent on a pressure gauge for the raw water intake pump. On 06/08/23, \$14.30 was spent on reciprocating saw blades. On 06/16/23, \$4.20 was spent on ear plugs for crews filling the raw water intake pump. On 06/20/23, \$7.21 was spent on nuts, bolts, and washers for meter installations.
