This letter is to inform you that Martin County Water District made zero (0) purchases from Evans Hardware in Quarter 2 of 2024.

Alliance Water Resources made sixteen (16) purchases in Quarter 2 of 2024.

On 4/10/24, \$28.59 was spent on copper tubing and a flare nut for Otto Brown pump station. On 4/10/24, \$7.41 was spent on copper fittings for Otto Brown pump station. On 4/16, \$5.28 was spent on compression fittings for the copper feed line at Otto Brown pump station. On 4/16, \$8.47 was spent on flare nuts for Otto Brown pump station.

On 5/7/24, \$79.50 was spent on a jack hammer rental for a leak repair. On 5/22/24, \$38.03 was spent on Electrical tape and bolts for Big Elk pump station. On 5/28/24, \$55.26 was spent on fittings for the chlorine analyzer at the Inez Water Treatment Plant.

On 6/1/24, \$21.27 was spent on an electrical cable and plug for the carbon mixer motor at the Inez Water Treatment Plant. On 6/6/24, \$18.01 was spent on trimmer line for grass cutting at the Inez Water Treatment Plant. On 6/10/24, \$14.82 was spent on couplings to repair a drain line at the Inez Water Treatment Plant. On 6/11/24, \$15.89 was spent on a trimmer head for grass cutting around pump stations. On 6/11/24, \$270.14 was spent on blacktop patch for highway 40 water line repair. On 6/12/24, \$17.48 was spent on trimmer line for grass cutting around pump stations. On 6/12/24, \$29.67 was spent on premix trimmer fuel for grass cutting. On 6/19/24, \$28.60 was spent on saw blades for water line repairs. On 6/19/24, \$11.90 was spent on a drill bit and screws for the Inez Water Treatment Plant.
