This letter is to inform you that Martin County Water District made zero purchases from Evans Hardware in the past 30 days.

Alliance Water Resources made six (6) purchases in December 2023. On 12/12/22, \$23.30 was spent on a brass coupling and a Sharkbite for a frost-free spigot at the WTP. On 12/19/22, \$12.66 was spent on a replacement electric outlet at the WTP. On 12/21/2022, \$25.38 was spent on pipe insulation at the WTP. On 12/22/2022, \$30.73 was spent on Ice Melt. On 12/23/22, \$10.59 was spent on a bale of straw for lawn repair after an excavation. On 12/30/2022, \$57.16 was spent on bolts, nuts and washers for repairs at a booster pump station.
