

Dear Commissioners,

This letter is to inform you that Martin County Water District made zero purchases from Evans Hardware in the past 30 days.

Alliance Water Resources made eleven (11) purchases in January 2023. On 1/4/23, \$148.38 was spent on chains and hooks for the heavy equipment trailer. On 1/6/2023, two (2) purchases in the amounts of \$5.91 and \$3.16 were spent on wire rope clips for repairs at a storage tank site. On 1/7/23, \$21.73 was spent on a check valve for repairs at a booster pump station. On 1/09/2023, \$24.37 was spent on a 4 pack of 1" x 10' ratchet straps for securing hauled loads. On 1/10/2023, \$30.20 was spent on a pressure switch for a booster pump station. On 1/12/2023 two (2) purchases in the amounts of \$116.59 and \$17.35 were spent on a new toilet, wax rings, and bolts for the water treatment plant. On 1/13/23, \$37.60 was spent on a heat lamp, GFCI outlet cover, and heat lamp clamp for booster station pump maintenance. On 1/23/2023, \$37.70 was spent on Redi-Mix and a finishing trowel for concrete repairs in the City of Inez. On 1/28/2023, \$28.77 was spent on a section of chain, nuts, bolts and washers for distribution repairs.
