Dear Commissioners,

This letter is to inform you that Martin County Water District made zero purchases from Evans Hardware in the past 30 days.

Alliance Water Resources made three (3) purchases in August 2022. On July 30th (Transaction did not post in time to be on previous report) \$41.32 was spent to purchase headlamps for power outages and entering pits at the water plant. On August 11th, plumbing materials were purchased for \$54.58 to install new piping and blowoffs for flowmeters. On August 15th, parts were purchased to install a new PRV at Turkey Creek pressure zone for \$163.07.
