Dear Commissioners,

This letter is to inform you that Martin County Water District made zero purchases from Evans Hardware in the last 30 days.

Alliance Water Resources made the following purchases during the month of August. On August 2<sup>nd</sup>, a chemical transfer pump broke. A temporary hand was purchased for \$10.24. On July 30<sup>th</sup>, our jack hammer failed during a job and one had to be rented locally to continue repairs \$79.50. On August 27<sup>th</sup>, two purchases were made. One for \$12.17 and one for \$5.61 were made for parts to repair the 645 pump station during a customer outage. All purchases were made at Evans due to the amount of time it would have taken to leave town. Customers were without water and it was deemed an emergency to make the repairs.
