Dear Commissioners,

This letter is to inform you that Martin County Water District made zero purchases from Evans Hardware in the past 30 days.

Alliance Water Resources made five (5) purchases in the amounts of \$4.23, \$32.72, \$11.64, \$7.60, and \$22.56 over the period of September 2<sup>nd</sup> and 3<sup>rd</sup> and \$9.53 on September 28<sup>th</sup>. These purchases were made to restore reliable service to customers on 645 booster pump station. An air hose, compression fittings and miscellaneous plumbing fittings were bought locally to ensure service was restored in prompt manner. The purchase on the 28<sup>th</sup> was for weed trimmer line while working around booster stations. In order to keep work moving in a timely manner, trimmer line was purchased at Evans instead of driving 35 minutes each way to another location.
