

Dear Commissioners,

This letter is to inform you that Martin County Water District made zero purchases from Evans Hardware in the past 30 days.

Alliance Water Resources made eight (8) purchases in October 2022. On September 1st, purchases of \$22.65 and \$2.11 were made for oil and funnel for the intake pump and a key made. On September 2nd, purchases of \$24.34 and \$3.49 were made for air compressor accessories. On September 15th, a purchase of \$14.30 was made for a socket for crews working on a water line repair. On September 21st, 16 keys were made for a total of \$39.64. On September 28th batteries were purchased for \$16.09 for leak detection equipment. Finally, On September 28th, \$58.29 was spent on a space heater which will be used at Spicy Ridge Kiosk building.
