Dear Commissioners,

This letter is to inform you that Martin County Water District made zero purchases from Evans Hardware in the past 30 days.

Alliance Water Resources made five (5) purchases in October 2022. On October 5th, purchases of \$22.09 and \$25.96 were made for a cover switch, wire nuts, masonry bits, screws and a 20-amp circuit breaker for the water treatment plant. On October 18th, \$38.97 was spent on compressor oil for the raw water intake pump. On October 20th, \$49.81 was spent on a 5-gallon bucket of hydraulic fluid for the distribution excavator.
