



This letter is to inform you that Martin County Water District made zero purchases from Evans Hardware in the past 30 days.

Alliance Water Resources made two (2) purchase in the amounts of \$19.07 on November 5<sup>th</sup> to purchase a torch for thawing out a dewatering pump during a break, and for \$211.98 on November 12<sup>th</sup> to purchase radios for flagging during breaks due to old radio failures. These purchases were deemed an emergency due to the immediate need during a line break event.
