On behalf of Louisville Water Company, thank you for attending the meeting of our wholesale customers last week. We hope you found the information we shared beneficial.

As previously discussed at the above meeting, the proposed wholesale commodity charge effective July 1, 2020 will be \$2.00 per thousand gallons, plus an elevated service area surcharge of \$0.41 per thousand gallons, for a total wholesale rate of \$2.41 per thousand gallons. This represents a 2.1% increase of our current rate.

We are planning to file the necessary documentation for this proposed new rate with the Public Service Commission (PSC) near the end of March. The PSC has advised us in the past that we must inform you of the proposed rate increase in the format of the notice attached on the next page, although we have already provided you notice at our wholesale customer meeting March 5, 2020.

Dear Mr. Chandler:

Please find attached information regarding the proposed increase in wholesale rates for water sold by Louisville Water Company (LWC) to the North Nelson Water District (North Nelson). North Nelson is currently a wholesale customer of Louisville Water Company pursuant to an Agreement dated January 15, 1996 between Kentucky Turnpike Water District and North Nelson. The agreement was filed with the Commission on May 13, 1998. A copy is attached as Exhibit 2.

Pursuant to the Public Service Commission Order entered September 6, 2000, in Case No. 2000-306 (In the Matter of the Application of the Louisville Water Company for Approval of the Merger and Acquisition of Ownership of Kentucky Turnpike Water District), the Commission approved the transfer of the assets of KTWD to LWC pursuant to the terms of a Merger and Acquisition Agreement between LWC and KTWD dated August 14, 2000. Under the terms of the merger, LWC acquired and assumed the obligations of the agreement between KTWD and North Nelson, and LWC continued to furnish water to North Nelson at the rates set forth in the KTWD agreement.

LWC and North Nelson entered into a Water Purchase Agreement dated February 25, 2004. This agreement called for the rates for water sold to North Nelson to be reduced to the wholesale rate established by the Board of Water Works Rules and Regulations of LWC which are the rates established for LWC's other wholesale customers. Because the agreement provided for a rate decrease, both parties agreed that the agreement would be effective immediately upon acceptance by the PSC (April 11, 2004). Also enclosed is a Water Purchase Agreement that details a second metering point for North Nelson.

In addition to discussions with individual wholesale customers, LWC had a general meeting with all the wholesale customers March 5, 2020. We are following the same wholesale rate increase process as in previous years. As a result, please find attached the following information and copies of the following documents:

Exhibit 1 - A copy of the thirteenth revised tariff sheets reflecting the proposed increased rates which are to be effective July 1, 2020.

Support documents in the following order –

Exhibit 2 - Agreement between Kentucky Turnpike Water District and North Nelson previously referred to above. The agreement was filed with the Commission on May 13, 1998. And, the current rates for wholesale sales of water by LWC to North Nelson are governed by the Water Purchase Agreement dated February 25, 2004 (Paragraph 4). The Water Purchase Agreement that details a second metering location, filed with the Commission November 7, 2009.

Exhibit 3 - LWC filed its original tariff governing the sale of water on a wholesale basis to North Nelson March 12, 2004. Attached are the last three wholesale rate increases, for historical reference.

- -The tenth revised tariff sheets reflecting the proposed increased rates which were effective July 1, 2017. LWC filing for North Nelson tenth revised tariff was TFS2017-00160.
- -The eleventh revised tariff sheets reflecting the proposed increased rates which were effective July 1, 2018. LWC filing for North Nelson eleventh revised tariff was TFS2018-00121.
- -The twelfth revised tariff sheets reflecting the proposed increased rates which were effective July 1, 2019. LWC filing for North Nelson twelfth revised tariff was TFS2019-00192.

Exhibit 4 - The proposed increased rates are supported by LWC's 2019 Cost of Service Study for 2020. A summary of the study with the new rate schedule is attached.

Finally, the notice provided to North Nelson relating to the proposed increase is also attached. It is in the revised format requested by the PSC.

LWC respectfully requests that the Commission accept the amendments to its tariff governing sales to North Nelson so that the proposed rate changes can be effective July 1, 2020.

The City of Bardstown hereby provides notice that it filed with the Public Service Commission on November 13, 2019 to increase its rates to the North Nelson and Larue County No.1 Water Districts. In addition the proposed rate schedule will also apply to the cities of Bloomfield and New Haven.

The Current Rate is \$2.00 per thousand gallons and was last raised in 2013. New rates are proposed to be implemented in five incremental steps, the first become effective for water service rendered on and after January 1, 2020 with a new rate per 1,000 gallons to become effective each July 1<sup>st</sup> as forth below:

### **RESOLUTION NO. 2020-05-01**

A RESOLUTION OF THE BOARD OF COMMISSIONERS OF THE NORTH NELSON WATER DISTRICT ADJUSTING WATER RATES AND CHARGES TO OFFSET THE LOUISVILLE WATER COMPANY AND THE CITY OF BARDSTOWN WHOLESALE RATE INCREASES

WHEREAS, the Louisville Water Company ("LWC") and the City of Bardstown ("Bardstown") are North Nelson Water District's ("District") wholesale water providers;

WHEREAS, on March 30, 2020 LWC filed an application with the Kentucky Public Service Commission ("PSC") seeking to increase the wholesale water rate that LWC charges the District from \$2.36 to \$2.41 per 1,000 gallons and seeking to increase the monthly meter fees that LWC charges the District (See PSC Case TFS2020-00148), effective July 1, 2020;

WHEREAS, on November 15, 2019 Bardstown filed an application with the PSC seeking to increase the wholesale water rate that Bardstown charges the District from \$2.45 to \$2.49 per 1,000 gallons (See PSC Case TFS2019-00625), effective July 1, 2020;

WHEREAS, based upon the water purchases from LWC and Bardstown during the previous 12 months and the increased monthly meter fees at both LWC

master meter locations, the estimated annual increased cost to the District will be \$13,984.83;

WHEREAS, prudent financial management dictates that the District take immediate action to adjust its retail rates commensurate with LWC's and Bardstown's wholesale rate increases; and

WHEREAS, KRS 278.015 and 807 KAR 5:068 provide the legal mechanism for the District to increase its water rates commensurate with LWC's and Bardstown's wholesale rate increases via a Purchased Water Adjustment ("PWA").

NOW, THEREFORE, IT IS HEREBY RESOLVED BY THE BOARD OF COMMISSIONERS OF NORTH NELSON WATER DISTRICT AS FOLLOWS:

Section 1. The facts, recitals, and statements contained in the foregoing preamble of this Resolution are true and correct and are hereby affirmed and incorporated as a part of this Resolution.

Section 2. The PWA factor is \$0.06 per 1,000 gallons;

Section 3. All tiers of water usage set forth in the District's existing tariff shall be increased by \$0.06 per 1,000 gallons, subject to any minor adjustment that may be made by the PSC.

Section 4. The monthly water rates to be charged to and collected from the customers and users of the water system of the District shall be as set forth in Appendix A, which is attached hereto and is incorporated herein by reference as a part of this Resolution. The rates and charges set forth in Appendix A are subject to any minor adjustment that may be made by the PSC. These monthly rates and charges shall be in effect for all water service rendered on and after July 1, 2019.

Section 5. The General Manager is hereby authorized and directed to execute and file the PWA Application, Tariff Sheet, and all other documents that may be required by the PSC.

Section 6. The General Manager, all appropriate District Staff, and the District's attorney are hereby further authorized and directed to take any and all other actions and to execute and deliver any and all other documents as may be reasonably necessary to implement the PWA.

Section 7. This Resolution shall take effect upon its adoption.
