MOTION FOR EXTENSION OF TIME

Ohio County Water District ("Ohio District") moves for an extension of time until July 27, 2020 to submit its responses to Commission Staff's Initial Request for Information. In support of its Motion, Ohio District states:

1. On June 29, 2020, Commission Staff issued its Initial Request for Information, which contained 30 requests. Some of these requests require a review and compilation of six years of business records. Other requests require the production of documents that are not in Ohio District's immediate possession

2. The request allows Ohio District only eight business days in which to compile that requested information. (July 3 is a federal and state holiday.)

3. Ohio District's Office Manager will be primarily responsible for responding to many of the requests. She was on scheduled vacation until July 6, 2020 and was unavailable to commence work on Ohio District's response until that date.

4. Moreover, the Office Manager is the only Ohio District employee with sufficiently familiarity and understanding of Ohio District's record systems and practices to compile much of the requested information and prepare Ohio District's response. To compile and assemble thorough and accurate responses to Commission Staff's Request within the allotted time period, the Office Manager would devote her full attention solely to preparing the responses. This is not possible without disrupting Ohio District's operations and significantly lowering the level of its customer

service. Ohio District has two office employees in addition to its Office Manager. During the weeks of July 6 and July 13, one of these two employees will be on a scheduled vacation and the Office Manager must perform the absent employee's duties if the office is to function adequately.

5. Extending the response period will enable Ohio District to provide more thorough responses to Commission Staff's Request and thus allow it to better assist the Commission's review of the proposed tariff revision. The requested extension will not unduly delay this proceeding.

6. This request is made in good faith and not for purposes of delay

WHEREFORE, Ohio County Water District requests that the Commission enter an Order extending the time for responses to Commission Staff's Fifth Request for Information to July 27, 2020.
