(e) <u>Other Matters</u> – The July 2022 Tariff C.C. filing is calculated in accordance with the methodology used in prior filings as amended to reflect the following:

(i) the recovery of \$2,692,329 (\$5,792,329 minus \$3,100,000 (50 percent of \$6,200,000)) in lieu of 12-month amount of \$6,200,000; *less*

(ii) estimated July 2022 Tariff C.C. revenues of \$542,925; *plus*

(iii) the recovery of the prior 12-months under-recovery of \$165,537 (Line 1(c) of the Capacity Charge Update_2022).

The resulting balance of \$2,692,329 will be collected over 4.23 months (July 29, 2022 (cycle 1 of the August billing cycle) to December 7, 2022) to reflect the termination of Tariff C.C. on December 7, 2022.

Any resulting over-recovery or under-recovery following the termination of Tariff C.C. will be credited to (or collected from) customers through Tariff P.P.A. in accordance with paragraph 3(e) of the settlement agreement approved with non-relevant modifications by the Commission's January 18, 2018 Order in Case No. 2017-00179.

A conforming tariff filing is being made using the Commission's electronic tariff filing system.
