**JOINT NOTICE OF KIUC AND THE ATTORNEY GENERAL  
REGARDING EXPERT WITNESS EXPENSE SHARING**

The intervenors, the Attorney General of the Commonwealth of Kentucky by and through his Office of Rate Intervention (“Attorney General”) and the Kentucky Industrial Utility Commission (“KIUC”), by counsel, provide notice of their filing of the attached agreement between the Attorney General and KIUC related to the above styled matter, as directed by the Public Service Commission in its Order entered August 13, 2020. Nothing in the agreement limits the independence of the positions that the Attorney General or KIUC might take in this action or the arguments they might make. The agreement merely reflects a mechanism to share the expenses of expert witnesses necessary to the prosecution of this matter. Furthermore, the agreement is not relevant to the underlying substantive issues raised by Kentucky Power’s application.
