**Motion For Deviation From The Commission's Orders With Respect
To The Publication Of The Notice Of Hearing**

Kentucky Power Company moves the Public Service Commission of Kentucky for a deviation from the requirements of the Commission's July 28, 2020 and August 5, 2020 Orders with respect to the publication in *The Licking Valley Courier* (Morgan County) and *The Elliot County News* of the notice of the hearing in this case scheduled to begin November 17, 2020.

Kentucky Power states in support:

1. Kentucky Power provided the required notice to Kentucky Press Service, Inc. in sufficient time for the timely publication of the required notice in each of the 20 counties in the Company's service territory. Kentucky Press Service contacted each of the newspapers and arranged for the publication of the notice in each publication on or before November 6, 2020.

2. Kentucky Power subsequently was informed by the Kentucky Press Service that *The Licking Valley Courier* (Morgan County) and *The Elliot County News* failed to publish the notices as scheduled. They now are scheduled to be published on November 12, 2020 (*The Licking Valley Courier*) and November 13, 2020 (*The Elliot County News*). Kentucky Power is unaware of the reason the two newspapers failed to publish the notice as originally scheduled.

3. The requested deviation will not prejudice the public or the Commission as notice of the hearing will be published prior to the hearing. Kentucky Power acted in good faith and with due care in arranging for the timely publication of the notices.

For the foregoing reasons, Kentucky Power requests that the Commission grant a deviation from the requirements of its July 28, 2020 and August 5, 2020 Orders.
