For the same reason, the Company seeks leave to make Confidential Attachments 1 through 6 to the Company's response to KPSC 2-22 available for inspection at the offices of Stites & Harbison PLLC in Frankfort, Kentucky in lieu of filing the same in paper medium with the Commission.
