b. The proposed construction is briefly described as follows:

The Fleming Solar Project will consist of approximately 1500 acres of solar photovoltaic panels and associated racking (approximately 188MW), 31 inverters, and a project substation transformer which will connect to East Kentucky Power Cooperatives Flemingsburg-Spurlock 138kv transmission line near the City of Flemingsburg in Fleming County, Kentucky.

- c. The street address of the proposed Fleming Solar Project is 3211 Convict Pike, Flemingsburg, KY 41041 and the latitude and longitude are 38 25'51.59" N and 83 47'17.67" W. The Fleming Solar Project is not located within the limits of any city.
- d. There is no planning or zoning commission with jurisdiction over the site.
- e. There are no local set-back requirements applicable to this site.
- f. Pursuant to KRS 278.704(4), the applicant will request a deviation from the setback requirements found in KRS 278.704(2).
