APPLICATION TO CONSTRUCT
MERCHANT ELECTRIC GENERATING FACILITY

Pursuant to KRS 278.706 and 807 KAR 5:110, AEUG Fleming Solar, LLC (f/k/a Tenaska Solar XIII, LLC), by counsel, submits this application for a construction certificate to construct a merchant electric generating facility. In support of this application, AEUG Fleming (“AEUG Fleming”) states as follows:

1. AEUG Fleming is a limited liability company organized under the laws of Delaware with a principal place of business of 55 E. Monroe St., Suite 1925, Chicago, IL 60603. AEUG Fleming’s phone number is (312) 870-1480. A copy of AEUG Fleming’s Certificate of Authority that is on file with the Kentucky Secretary of State’s office is submitted as Attachment I to the Application.

2. The proposed AEUG Fleming Solar Facility will be a 188-megawatt alternating current (MWac) photovoltaic electricity generation facility. The project is to be located in Fleming County, at 3211 Old Convict Pike, Flemingsburg, KY 41041. The power generated by the project will be sold on the open market through the existing transmission line that crosses the property.


3. Pursuant to KRS 278.706 and 807 KAR 5:100, AEUG Fleming hereby submits its application fee of \$188,000.00 with this filing.


