Notification of Surcharge Fee Cessation

Farmdale District last billed its customers the Surcharge Fee on **July 25, 2024**. Finding paragraph 5 of the Commission’s July 7, 2020 Order in Case No. 2020-00021, the rate adjustment proceeding which gave rise to the Water Loss Reduction Surcharge, states: “Farmdale District should be authorized to assess a monthly surcharge of \$3.00 per customer for **48 months**, or until \$380,000 has been assessed, whichever occurs first. . .”¹ Farmdale District first billed its customers for the Surcharge on **August 27, 2020**.² Farmdale assessed the Surcharge on customer bills for 48 months and did not exceed the maximum \$380,000. Farmdale District has arranged with its billing software provider to remove the Surcharge Fee from the customer bills beginning with the August 26, 2024 bill.

Farmdale District will continue to file Monthly Water Loss Reports and Monthly Surcharge Activity Reports, along with Surcharge Account bank statements, into the record of this proceeding until all Surcharge proceeds are expended, pursuant to the Commission’s July 7, 2020 Order in this proceeding.
