APPLICATION TO CONSTRUCT
MERCHANT ELECTRIC GENERATING FACILITY

Pursuant to KRS 278.706 and 807 KAR 5:110, AEUG Madison Solar, LLC (f/k/a Tenaska Solar VIII, LLC), by counsel, submits this application for a construction certificate to construct a merchant electric generating facility. In support of this application, AEUG Madison (“AEUG Madison”) states as follows:

1. AEUG Madison is a limited liability company organized under the laws of Delaware with a principal place of business of 55 E. Monroe St., Suite 1925, Chicago, IL 60603. AEUG Madison’s phone number is (312) 870-1480. A copy of AEUG Madison’s Certificate of Authority that is on file with the Kentucky Secretary of State’s office is submitted as Attachment I to the Application.

2. The proposed AEUG Madison Solar Facility will be a 100-megawatt alternating current (MWac) photovoltaic electricity generation facility. The project is to be located in Madison County, at 2146 Red House Road Richmond, KY 40475. The power generated by the project will be sold on the open market through the existing transmission line that crosses the property.


3. Pursuant to KRS 278.706 and 807 KAR 5:100, AEUG Madison hereby submits its application fee of \$100,000.00 with this filing.


