This is to certify that the Kentucky Water Resources Research Institute completed two virtual workshops in support of KRS 74.020(6) and KRS 74.020(7) from August 25, 2020 through August 26, 2020 and from September 2, 2020 through September 30, 2020. The workshops were conditionally approved by the PSC on July 22, 2020 (case number 2020-00222).
