**APPLICATION TO CONSTRUCT
MERCHANT ELECTRIC GENERATING FACILITY**

Pursuant to KRS 278.706 and 807 KAR 5:110, Mt Olive Creek Solar, LLC (“Mt Olive Creek”), by counsel, submits this application for a construction certificate to construct a merchant electric generating facility. In support of this application, Mt Olive Creek states as follows:

1. Mt Olive Creek is a limited liability company organized under the laws of North Carolina with a principal place of business of 400 W. Main St., Suite 503, Durham, North Carolina 27701. Mt Olive Creek’s phone number is (919) 682-6822. A copy of Mt Olive Creek’s Certificate of Authority that is on file with the Kentucky Secretary of State’s office is submitted as an attachment to the Application.

2. The proposed Mt Olive Creek Solar Facility will be a 60-megawatt alternating current (MWac) photovoltaic electricity generation facility. The project is to be located in Russell County, at approximately 481 Sano Rd, Russell Springs, KY 42642 and the latitude and longitude are 37° 6'21.61"N, 85° 5'16.34"W.

3. The power generated by the project will be sold on the open market through the existing transmission line that crosses the property.


4. Pursuant to KRS 278.706 and 807 KAR 5:100, Mt Olive Creek hereby submits its application fee of \$60,000.00 with this filing.


