Supplemental Response

In Unbridled's February 2, 2021 Data Request response to ESB 07, Unbridled stated that there were two property owners who had expressed concerns with their viewshed at the public information meeting open hours in August 2020, attached a written approval of the screening plan from the owner of neighboring property PID #71-47, and reported that discussions were ongoing with the second property owner regarding the screening plan.

Unbridled would like to supplement its initial response with the following:

The second property owner who expressed concerns, the owner of neighboring property PID #72-2, has reviewed and agreed to the screening plan, consistent with the screening plan proposed in Unbridled's application and Exhibit K. A copy of that owner's written approval (with personal information redacted per 807 KAR 5:001 § 4(10)) is attached to this response.

As of March 2021, Unbridled has come to a screening plan agreement with both neighboring landowners referenced in the initial response to Data Request ESB 07.
