**ATTORNEY GENERAL’S AND KENTUCKY-AMERICAN**  
**WATER COMPANY’S JOINT**  
**STATEMENT REGARDING SUBMISSION OF CASE**

The Attorney General of the Commonwealth of Kentucky, by and through his Office of Rate Intervention (“OAG”), and Kentucky-American Water Company (“KAW”) hereby submit their joint statement regarding submission of this case for a decision. Pursuant to the Commission’s October 29, 2020 Order in this matter, the parties are required by December 9, 2020 to either request a hearing or state whether the case can be submitted on the existing record. The OAG and KAW agree that a hearing is not necessary and that the case should be submitted for a decision on the record after each party files a brief stating their respective positions. They further agree and respectfully request that they be permitted to file those briefs no later than December 9, 2020 and that the matter then be submitted for a decision without a hearing.




