Kentucky-American Water Company (“KAW”) hereby updates its October 28, 2020 filing with the updated amount for which it seeks regulatory asset treatment. KAW’s October 28, 2020 filing was current through September 30, 2020 and totaled \$1,055,890. KAW hereby updates that amount to \$1,196,603 which is current through October 30, 2020. The update is for amounts only. The categories of costs have not changed. As KAW has indicated in this matter, the amount at issue is expected to continue to evolve and KAW will continue to provide updated information as appropriate. 


