**MOTION TO WITHDRAW**

---

The City of Harrodsburg (“Harrodsburg”), by counsel, respectfully moves the Public Service Commission ("Commission") for permission to withdraw its proposed wholesale rate increase. In support of the motion, Harrodsburg states as follows:

On July 14, 2020, Harrodsburg filed with the Commission a revised tariff sheet setting forth proposed adjustments to its existing rate for wholesale water service to Lake Village Water Association and North Mercer Water District effective on September 1, 2020. Harrodsburg proposed to increase the wholesale water rates by only 2.3 percent. The wholesale purchasers did not object to the proposed increase. On August 20, 2020, the Commission entered an order establishing this proceeding to investigate the reasonableness of the wholesale rates. Based on a review of prior municipal wholesale rate cases before this Commission, it appears that rate case expense for this matter would likely exceed the increase in annual revenue generated from the proposed rates. Accordingly, Harrodsburg seeks to withdraw its proposed wholesale rate increase.

Harrodsburg respectfully requests that this motion be considered Harrodsburg’s notice of appearance, as required by ordering paragraph 4 of the Commission’s August 20 Order. In

addition, Harrodsburg acknowledges that it waives any right to service of Commission Orders by United States mail and that the undersigned counsel, as Harrodsburg's agent, possesses the facilities to receive electronic submissions. To the extent necessary, Harrodsburg seeks leave of the Commission to file this notice of appearance and acknowledgement after the deadline set by the August 20 Order.
