Pursuant to KRS 278.706 and 807 KAR 5:110, Flat Run Solar, LLC (“Flat Run”), by counsel, submits this application for a construction certificate to construct a merchant electric generating facility. In support of this application, Flat Run states as follows:

1. Flat Run is a limited liability company organized under the laws of North Carolina with a principal place of business of 400 W. Main St., Suite 503, Durham, North Carolina 27701. Flat Run’s phone number is (919) 682-6822. A copy of Flat Run’s Certificate of Authority that is on file with the Kentucky Secretary of State’s office is submitted as an attachment to the Application.

2. The proposed Flat Run Solar Facility will be a 55-megawatt alternating current (MWac) photovoltaic electricity generation facility. The project is to be located in Taylor County, at approximately 5347 Saloma Rd., Campbellsville, KY 42718. The power generated by the project will be sold on the open market through the existing transmission line that crosses the property.


3. Pursuant to KRS 278.706 and 807 KAR 5:100, Flat Run hereby submits its application fee of \$55,000.00 with this filing.


