

This letter is in response to your correspondence received by the Public Service Commission on September 11, 2020. You have requested a copy of the information provided to Lowell Ray and Gladys Rice in a letter regarding the placement of the cell phone tower East Kentucky Network, LLC ("EKN") seeks to construct in Campton, Kentucky.

Per your request, a copy of the notification letter dated August 27, 2020, which EKN previously sent to Lowell Ray and Gladys Rice is enclosed for your records. Kentucky regulations require a notification letter be sent to every person who, according to the records of the property valuation administrator (PVA), owns property within 500 feet of a proposed cellular tower. It appears the PVA records for Wolfe County have not been updated to reflect your ownership of the property in question, which is why a notification letter was not sent directly to you.

EKN greatly appreciates you reaching out to discuss the placement of a cellular tower on your property. However, a location near your property has already been submitted to the appropriate authorities for the lengthy and costly regulatory review process required by law.

East Kentucky Network, LLC d/b/a Appalachian Wireless has applied to the Public Service Commission of Kentucky for a Certificate of Public Convenience and Necessity to construct and operate a new facility to provide cellular telecommunications service in Wolfe County. The facility will include a 300-foot self-supporting tower with attached antennas extending upwards, and an equipment shelter located on a tract of land at 1348 Quillens Chapel Road, Campton, Wolfe County. A map showing the location of the proposed new facility is enclosed. This notice is being sent to you because you may own property within a 500' radius of the proposed tower or own property contiguous to the property upon which construction is proposed.

The Commission invites your comments regarding the proposed construction. You also have the right to intervene in this matter. The Commission must receive your initial communication within 20 days of the date of this letter as shown above.
