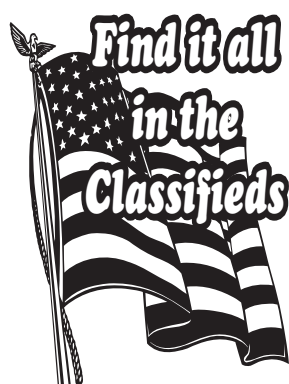
NOTICE OF PUBLIC HEARING
