NOTICE OF FILING AND NAME CHANGE

Daviess County Water District (“Daviess District”), successor to the Southeast Daviess County Water District (“Southeast District”) and the West Daviess County Water District (“West District”) by way of merger and name change, hereby provides notice that it is filing herewith Executive Order #08-2020 signed by the Daviess County Judge/Executive on December 3, 2020, which approved the annexation of territory and the name change.

Ordering Paragraph 3 of the attached Executive Order ordered all land encompassed within the current territorial boundaries of West District to be annexed and made part of Southeast District upon the Closing of the Merger, and also ordered the name of Southeast District to be changed to “Daviess County Water District,” effective with the Closing of the Merger. The Closing of the Merger was January 1, 2021.

EXECUTIVE ORDER # 08-2020

ORDER ANNEXING TERRITORY AND CHANGING NAME OF
MERGED WATER DISTRICT TO DAVIESS COUNTY WATER DISTRICT

WHEREAS, this matter is before the Daviess County Judge/Executive upon the petition of the Southeast Daviess County Water District (the "Southeast District") seeking to enlarge its territorial limits by annexing all the land encompassed within the current territorial boundary of the West Daviess County Water District (the "West District") and to change the name of the Southeast District to the "Daviess County Water District" upon the closing of the proposed merger. The petition was filed with the Daviess County Judge/Executive on October 21, 2020;

WHEREAS, the Daviess County Judge/Executive, by Executive Order entered on October 22, 2020, scheduled this matter for a public hearing on the question of whether it is reasonable for Southeast District to annex all the land encompassed within the current territorial boundary of the West District;

WHEREAS, reasonable notice of the public hearing has been given by publishing a Notice of Public Hearing in the October 29, 2020 and November 19, 2020 editions of the *Messenger-Inquirer* as required by KRS 74.110(2) and (3) and KRS Chapter 424;

WHEREAS, the West District is the only utility providing potable water service to the area sought to be annexed by the Southeast District;

WHEREAS, on August 18, 2020, the Southeast District and the West District entered into a Merger Agreement (the “Merger Agreement”) whereby the West District will merge with and into the Southeast District (the “Merger”). The Southeast District will be the surviving water district. In conjunction with the proposed Merger, the Southeast District desires to change its name to the “Daviness County Water District;”

WHEREAS, one of the closing requirements set forth in Section 6.5 of the Merger Agreement is that the Southeast District must obtain an Order from the Daviness County Judge/Executive expanding the territorial boundaries of the Southeast District to include all the land encompassed within the current territorial boundary of the West District.
