JOINT MOTION FOR AN EXTENSION OF TIME TO FILE BRIEF

Louisville Gas and Electric Company (“LG&E”), Kentucky Utilities Company (“KU”), Kentucky Power Company (“Kentucky Power”), and Duke Energy Kentucky, Inc. (“Duke Energy”) (collectively, the “Joint Movants”), by counsel, hereby move the Public Service Commission (“Commission”) to enter an order extending the deadline for all parties to file their briefs by 30 days. Pursuant to the Commission’s Order dated February 16, 2021, briefs are due within 30 days from the date of the Order. As grounds for their Joint Motion, the Joint Movants state that the issues under consideration in this proceeding are complex and require careful analysis to brief properly, particularly with the addition of the impacts of FERC Order No. 2222 to this proceeding’s scope. The Joint Movants therefore respectfully ask the Commission to extend the deadline by 30 days to allow all parties to provide briefs to the Commission that are thoroughly considered and most likely to be useful to the Commission.

The request for this brief extension of time will not prejudice the Commission or the parties in this proceeding and is not made for the purpose of delaying the Commission’s investigation.

WHEREFORE, Louisville Gas and Electric Company, Kentucky Utilities Company, Kentucky Power Company, and Duke Energy Kentucky, Inc. respectfully request the Commission issue an order granting all parties an additional 30 days to file their briefs.


