Response: The information provided in the response to Commission Staff's First Request for Information, Item 2, Attachment A includes Kenergy's total distribution system load, which is the rural load. It does not include direct serve load served by Big Rivers' transmission system or smelter load served by the market because these loads are not supplied by Kenergy's distribution system.

The rural load is the total load supplied by Kenergy's distribution system at the Response:

system. The direct serve loads are metered and billed by Big Rivers at their individual peaks,

non-coincident with Big Rivers' system peak. The aluminum smelter's market power is supplied

by and billed by EDF Trading North America, LLC. As requested, Attachment A to this response

shows the total net meter installed capacity on Kenergy's distribution system and the

corresponding total load on Kenergy's distribution system (the rural load). Kenergy is also

providing the direct serve industrial non-coincident load supplied by Big Rivers' transmission

system and the aluminum smelter load supplied by EDF Trading North America, LLC.
