This letter responds to Commission Staff's First Request for Information.

On March 14, 2023, Hyden-Leslie County Water District ("the District") issued Check No. 4426 on its Water Revenue Fund Account with Hyden Citizens Bank in the amount of \$5,727.68 and deposited that check into its PSC Surcharge Account with the same banking institution. A copy of this check and the receipt for this deposit is enclosed. The deposit receipt shows that \$5,727.68 was deposited on March 14, 2023, to an account with an account number ending in 6709. A review of the district's surcharge reports filed prior to March 14, 2023, will show similar deposit receipts made to the same Hyden Citizens Bank account number. These deposits are reflected on the bank statements for the District's PSC Surcharge Account.

Unfortunately, in the case of the March 14, 2023 deposit, Hyden Citizens Bank mistakenly deposited this check into the District' Water Revenue Fund Account. As the attached transaction log for the PSC Surcharge Account shows, this error was discovered and corrected on April 13, 2023 when Check No. 4426 was properly transferred from the District's Water Revenue Account to its PSC Surcharge Account
