**MOTION TO SUBMIT CASE FOR ADJUDICATION  
ON THE ADMINISTRATIVE RECORD AND  
WAIVER OF RIGHT TO HEARING**

Comes now Citipower, LLC (“Citipower”), by counsel, and hereby moves the Kentucky Public Service Commission (“Commission”) to submit the case for a decision based upon the existing record and without the need for a hearing, respectfully stating as follows:

On November 25, 2020, the Commission issued an Order establishing the procedural schedule in this proceeding. The procedural schedule allowed for two rounds of data requests and a deadline for motions to intervene in the case. Citipower has provided all of the requested information and there have been no motions for intervention filed in this case. Citipower has until February 19, 2021, to request a hearing or submit the case for a decision on the existing record.

Since there are no intervenors in this case and since the only remaining item on the procedural schedule is to request a hearing or submit for a decision on the existing record, Citipower believes the administrative record is complete and it would be appropriate for the Commission to make a ruling based upon the record. Citipower respectfully waives the right to a hearing and requests a decision from the Commission based upon the existing record.

WHEREFORE, Citipower moves the Commission to submit the case on the existing administrative record.
