- 1. Refer to Salt River Electric's Supplemental Response to Order (Supplemental Response), pages 4 and 12, where Salt River Electric details its attempts to communicate with prepay customers.
 - a. Provide copies of "the automated daily text and/or email messages, beginning in September, warning that service is "Pending Auto Disconnect" when a balance was negative."

Response: Examples of the automated daily text and email messages sent by Salt River Electric alerting delinquent prepay members of "Pending Auto Disconnect" are attached at Pages 3 and 4 of this response. A detailed record reflecting each of the 34,000+ automated messages sent during the relevant month-long time period is included as part of the "Member Contact Spreadsheet" provided herewith under seal.¹

b. Provide a transcript of the "[a]utomated calls beginning on October 14, requesting that members get in touch to avoid service interruption."

Response: Please see the document attached at Page 5 of this response.

c. Describe how Salt River Electric would determine whether a prepay customer could not be reached by automated call, text, or email.

Response: Salt River Electric utilizes an automated phone system provided by a third party (Milsoft) to contact members with past-due balances. The system is capable of generating a report that reflects the success of each phone call placed within each automated call campaign. The results of the automated call campaign conducted by Salt River Electric to its delinquent

prepay members on October 14, 2020, are reflected in the report provided at Page 6 through Page 33 of this response. As reflected in the report, the October 14th campaign had a successful call answer/receipt rate of approximately 92%.

Salt River Electric personnel reviewed the relevant report following the October 14th campaign to determine which members were not reached by the automated call, thereafter sending to those members an email with a copy of a letter requesting further communication (provided at Page 34 of this response). If that email was undeliverable or otherwise "bounced back" to Salt River Electric, the cooperative's personnel then mailed a hardcopy of the letter to any mailing address on file.

Finally, with respect to the twice-daily automated text messages sent by Salt River Electric to delinquent prepay members beginning in September and continuing through October 21, Salt River Electric was notified via system email if a text message sent to a prepay member was unsuccessful, at which point Salt River attempted to update the member's contact information utilizing the available email address or other information, if possible.

d. Provide a copy of the letter that Salt River Electric sent to prepay customers who could not be reached by automated call, text, or email.

Salt River Electric Cooperative Corporation Case No. 2020-00347 Commission Staff's First Request for Information

2. State whether Salt River Electric manually telephoned prepay customers before disconnecting service. If the answer is in the negative, explain why Salt River Electric did not manually telephone prepay customers who were to be disconnected.

Response: While Salt River Electric did engage extensively with the vast majority of its delinquent prepay members in the days and weeks leading up to October 21/22, Salt River Electric did not contact each of its delinquent prepay members via manual telephone call prior to discontinuing service on October 21/22.

As described in Salt River Electric's Supplemental Response, the cooperative orchestrated direct automated call campaigns to each of its delinquent prepay members on October 14, 2020, and October 20, 2020. These campaigns supplemented the cooperative's twice-daily text messages sent to each delinquent prepay member concerning his or her account. Moreover, as explained in response to Item 1(c) above, Salt River Electric exhausted all reasonable avenues to contact any member who Salt River Electric had reason to suspect did not receive or answer an automated call on October 14, including by email and physical mail when it appeared necessary.

Six days after the initial automated call campaign directed at delinquent prepay members, Salt River Electric conducted a second automated call campaign on October 20, 2020. This campaign, similar to its predecessor, had a successful call answer/receipt rate of roughly 90%, as reflected in the report provided at Page 2 through Page 32 of this response. Thereafter, the cooperative's personnel did begin contacting delinquent prepay members via manual phone calls where possible. However, after only a few calls, it became apparent that an additional phone call was unlikely to benefit the members, who consistently expressed that they neither expected nor wanted to be contacted again. (Notably, manual calls are almost invariably made to the same number as the automated calls and the twicedaily text messages.)

Additionally, due to the success of the automated call campaigns and other efforts of the cooperative, Salt River Electric's member service personnel was facing significantly-increased call volume at this time (2x normal, or roughly 4,000 calls per day) and thus the cooperative's limited resources were directed to those efforts. Overall, Salt River Electric believes it made every reasonable, appropriate and legally-required effort to contact its delinquent members prior to disconnecting continued service, and certainly at no time intended to willfully (or unwittingly) violate the Commission's directives in this regard.

3. Refer to the September 21, 2020 Order in Case No. 2020-00085, page 10, where the Commission stated that:

Utilities must also keep detailed records describing their attempts to communicate with customers with past due accounts or who will otherwise be subject to disconnection. Similar to the requirements in 807 KAR 5:006, Section 10(2), these records should reflect the customer's name and address, the dates and nature of the communication, and the agreed-upon payment plan (if any). Upon request by the Commission, these records shall be timely made available for review.²

Provide these records for the prepay customers that were disconnected.

Response: As discussed in Salt River Electric's Supplemental Response and the responses to the preceding two data requests, Salt River Electric has undertaken significant, coordinated efforts to ensure its membership remains well-informed and up-to-date with respect to relevant obligations and opportunities concerning arrearages accrued during the disconnect moratorium. Some of these efforts focused on the community at-large, including many account nonspecific communications posted in public places designed for broad outreach.³ Other efforts have been specifically aimed at delinquent accounts, including extensive automated phone call and email/text message campaigns,⁴ as well as hundreds of human-to-human phone calls during which the overarching goal has been accommodation and cooperation. The Member Contact Spreadsheet provided herewith under seal reflects the cooperative's detailed records of its communications with the relevant prepay members.
