In its Orders dated June 30, 2021 in the above referenced cases, the Commission approved Kentucky Utilities Company's (KU's) and Louisville Gas and Electric Company's (LG&E's) (jointly, the "Companies") Economic Relief Surcredits (ERS) which provided for bill credits to customers for twelve months beginning with the effective date of new base rates and a one month true-up credit or charge billed in the fifteenth billing month following approval. The Companies herewith file updated Exhibits RMC-1, RMC-2, and RMC-3 supporting the Companies' ERS True-up Rates to be billed during the September billing cycle which begins on August 30, 2022.

Some of the information provided in Exhibit RMC-2 is confidential for the same reasons set forth in the Companies' Petition for Confidential Protection filed with the original application on November 25, 2020. Said Petition was subsequently approved by Commission Order on December 7, 2021. Pursuant to 807 KAR 5:001, Section 13(2)(e) and subject to the terms of the Commission's July 22, 2021 order in Case 2020-00085 (Electronic Emergency Docket Related to the Novel Coronavirus COVID-19), the Companies will submit under separate cover an electronic version of the confidential information to the Commission
