**MOTION OF JOINT INTERVENORS MOUNTAIN ASSOCIATION, KENTUCKIANS
FOR THE COMMONWEALTH, AND KENTUCKY SOLAR ENERGY SOCIETY TO
ALLOW VIRTUAL HEARING PARTICIPATION BY EXPERT WITNESSES**

Come the Joint Intervenors Kentucky Solar Energy Society, Kentuckians for the Commonwealth, Mountain Association (Case No. 2020-00349), and Metropolitan Housing Coalition (Case No. 2020-00350), (collectively "Joint Intervenors"), and respectfully move the Public Service Commission ("Commission") to allow Joint Intervenor expert witnesses James Owen and Karl Rábago to testify at the hearing scheduled for August 17 and August 18, 2021, by virtual means rather than in-person attendance at the hearing.

Joint Intervenors believe that there exists good cause to excuse witnesses Owen and Rábago from in-person attendance. As reflected in the attached letter from Witness Owen, he has both health concerns and logistical problems that would make his in-person attendance both unnecessarily risky, but also extremely inconvenient due to family obligations. As witness Owen explains:

I am currently in quarantine, awaiting a test for COVID. There is a real risk that I could become a carrier of the Delta variant and infect citizens of the Commonwealth as a result of exposures I would experience *en route*. I am especially concerned about the high transmissibility of the variant, the need to move through and spend extended time in enclosed spaces.

In addition, in-person appearance raises a significant health risk to me and my family due the current COVID outbreak. I am concerned about the risk that if I acquire a breakthrough case, I will become a carrier of the virus back into my home, my community, and the places I pass through in travel. I have a three-and-a-half-year-old who cannot be vaccinated.

Further, my wife is traveling out of state that very week and I would have to find child care for my daughter. While I understand it is a normal course of action to travel for someone who holds themselves out as an expert witness, I would again note that I have never been cross-examined in any of these proceedings and requiring my presence would be unnecessary.

In addition, actual travel will be quite costly. My clients in this proceeding are not-for-profit organizations with limited budgets. My travel could impose unnecessary financial burdens on these organizations.

Witness Owen received confirmation on August 2, 2021 that he has tested positive for COVID-19, despite having received vaccinations. In-person attendance under such circumstances would place the witness and others at unnecessary risk of exposure and illness.

Similarly, with respect to witness Rábago, there are legitimate health concerns related to in-person attendance and related travel exposures.

As noted in his letter, which is attached to this Motion,

There is a real risk that I could become a carrier of the Delta variant and infect citizens of the Commonwealth as a result of exposures I would experience en route. I am especially concerned about the high transmissibility of the variant, the need to move through and spend extended time in enclosed spaces. In addition, in-person appearance raises a significant health risk to me and my family due to the current COVID-D outbreak. I am concerned about the risk that if I acquire a breakthrough case, I will become a carrier of the virus back into my home, my community, and the places I pass through in travel. I am 63 years old and my wife is 69, so I personally concerned about the health risks to my immediate family as well.

In addition, actual travel will be quite costly. My clients in this proceeding are not-for profit organizations with limited budgets. My travel could impose unnecessary financial burdens on these organizations.

Additionally, in earlier proceedings in both these cases and the recently concluded Kentucky Power Company Case, Case No. 2020-00174, both witnesses Owen and Rábago were able to fully participate and be available for cross-examination and questioning from the Commissioners without problem.

Finally, as noted by witness Rábago, in both the Kentucky Power Company case, No. 2020-00174, and in the initial hearing in these consolidated cases, there were very few questions posed to either of the witnesses by any party. Given the risks of travel, the costs of travel, the very limited cross-examination made of either witness to date in this and in the prior NMS hearing in the Kentucky Power Company case, and the ability to make both witnesses available for affirmation of direct testimony and data responses and for cross-examination, Joint Intervenors respectfully request that both witnesses Owen and Rábago be excused from in-person attendance at the hearing scheduled for August 17-18, 2021 and that provision be made for their virtual participation by Zoom or similar virtual conferencing platform.


