SECOND SUPPLEMENTAL STATUS UPDATE

Bluegrass Wireless LLC, Kentucky RSA #3 Cellular General Partnership, Kentucky RSA #4 Cellular General Partnership, and Cumberland Cellular Partnership (collectively, “Bluegrass Cellular”), by counsel, and in supplement to the Status Updates filed in the above-styled matter on December 17, 2020, and January 19, 2021, respectively, hereby respectfully state as follows.

As earlier reported, the acquisition of Bluegrass Cellular by Verizon Communications Inc. (“Verizon”)—*i.e.*, the transaction underpinning Bluegrass Cellular’s request herein to relinquish its designations as an Eligible Telecommunications Carrier (“ETC”) in Kentucky—remains expected to close on or about March 5, 2021. In its immediately prior Status Update, Bluegrass Cellular committed to sending its remaining Lifeline customers at least thirty (30) days advance notice of the rescheduled effective date for Bluegrass Cellular’s intended discontinuance of Lifeline service, and Bluegrass Cellular attached to that Status Update copies of the notices it intended to send.¹ Bluegrass Cellular hereby confirms it sent those notices to its remaining Lifeline customers on January 27, 2021.

Consistent with the foregoing, Bluegrass Cellular respectfully requests Commission authorization to relinquish its ETC designations effective March 5, 2021, concurrent with the closing of the transaction with Verizon. If possible, Bluegrass Cellular also asks that an Order granting its requested relief be entered by the Commission as soon as practicable (ideally by mid-February), thereby imparting finality to this aspect of the relevant transaction.
